Dear Parents/Guardians,

In order to observe safety and security for the students in the school campus and outside, the school management has decided to maintain certain norms which are mandatory for all.

1. If parents/ guardians wish to meet the Principal/Teacher In-charge/ any teacher, they should enter the school campus in proper attire (No half pants/Bermuda/lungi etc.).
2. Whenever a student requires leave for more than 3 days, he/she should come along with the parent with the application having proper and valid reason. In case of absence due to medical reasons, the student will come along with the parent with doctor's prescription and fitness certificate otherwise he/she may not be allowed to attend his/her classes. If any student wants to leave the school campus in between school hours on medical grounds, he/she will be handed over to the parents or authorized guardian only.
3. Every student must possess proper Identity Card of the school as well as Bus Pass (in case of Bus Users) with him/her.
4. Students are not permitted to use motorbike or scooty for commuting to the School. If found so, School authorities may take severe action.
5. No vehicle (Two wheeler/Four wheeler/Autorickshaw) will enter the campus at the time of pick and drop of the children w.e.f 06.08.2019. This should be abided by every parent very strictly. Parents who want to pick/drop their ward by their own vehicle may do so from Gate No. 2 (West of Block B) with the help of the guard. They can park their vehicle in between Block A and Block B on the road, if needed.
