## BUS RULES

1. Every student should always carry **BUS PASS** provided by the School with him/her. Student may be fined if the same is not produced during the checking.
2. Bus fees, as fixed by the School, should be paid regularly with the Tuition fees.
3. Transport facility will be provided only if the Bus Stoppage choice given by the parent is serviced by that particular School Bus Route.
4. The School does not entertain any request for changing of Bus Stops and Bus Routes to suit any individual student's convenience.
6. **It is not possible to entertain any request for discontinuing the Bus facility during the academic year.**
7. Parents should send their ward to the Bus Stoppage in proper time. They should also collect their ward from the Bus Stoppage as per the timing laid by the School. School should not be held responsible after final dispersal of students from Bus Stoppages.
8. The student must reach the Bus Stoppage at least 10 minutes before the scheduled time.
9. All students, availing the Bus facility provided by the School, are expected to remain disciplined during their journey. They should not misbehave with the staff.
10. The bus facility will be withdrawn immediately in case your ward is found guilty of any one of the following :
  - i) Change of buses
  - ii) Change of Stoppage
  - iii) Socially unaccepted behaviors in the bus.
